ADDENDUM

Application distances revised following changes in the *Pesticides Act* occured in August 2014



PREAMBLE

Following a *Pesticides Act's* amendment occurred in August 2014, the Ministère du Développement durable, de l'Environnement et de la Lutte contre les changements climatiques (responsible for the *Pesticides Act*) mandated SOFAD to adjust learning guides.

The Learning Guide significant changes concern the name and the definition of "catchment works" that is now referred to as "water withdrawal site", as well as the application distances to meet.

LEARNING GUIDE

Please incorporate the following corrections in your Learning Guide.

Page 4.23

In the box "A few definitions", the second paragraph should now be read:

A "water withdrawal site" includes facilities used for the production of spring water or mineral water, the supply of a waterworks, water withdrawal site designed for surface water or groundwarer intake for water intended for human consumption or any other groundwater water withdrawal site.

Page 4.25, Exercice 4.2, No. 3c

c) an underground water withdrawal site and supplying a summer cottage located in a forest?

Target for protection	Storage

About the targets for protection:

Category 1 water withdrawal sites¹: Water withdrawals carried out for a municipal waterworks system supplying over 500 persons and at least one residence.

Category 2 water withdrawal sites: water withdrawals carried out to supply a municipal waterworks system supplying between 21 and 500 persons and at least one residence; any other waterworks system supplying 21 or more persons and at least one residence; a system, independent of a waterworks system, supplying at least 21 or more persons and one or more of the following institutions within the meaning of the *Regulation respecting the quality of drinking water*: health or social services, education or detention facilities

Bottled water withdrawal sites: Water withdrawals carried out to produce spring water or mineral water according to the *Regulation respecting bottled water* (chapter P-29, r2).

Category 3 water withdrawal sites: water withdrawals carried out to supply a system independent of a waterworks system, supplying only one or more food processing establishments; a system independent of a waterworks system supplying only one or more enterprises, one or more tourist establishments or one or more seasonal tourist establishments within the meaning of the *Regulation respecting the quality of drinking water*; any other system supplying no more than 20 persons.

Other underground water withdrawal sites

All other sites of underground water withdrawal not intended for human consumption, food processing or bottled water purposes.
